Circlewood Board Meeting Minutes September 30, 2020, 3:00 pm, via Zoom

Present: Glenn Palmberg, James Amadon, Mike Holmgren, Tim Hedberg, Lenore Three Stars, Tom Ruebel, Forrest Inslee, Beth Knox, Louise Conner, Guest: David Jones

Check in: James shared a poll, with questions about each board members to open the meeting and begin check-ins. Glenn opened the meeting in prayer. A motion was made to approve the minutes as amended. The motion was seconded and passed.

Glenn and James presented the "Board Nomination Process, Guidelines, and Current Board Member Terms" proposal to the board. Proposed terms are intended to stagger terms and listed start dates are somewhat artificial in order to accomplish this aim. Glenn and James proposed that the Board adopt the proposed 6 steps as our board nomination process and guidelines from this day forward, and the term descriptions of current members as outlined. Discussion was held on which term this should be for Forrest. His current term was changed to his first term from second term. The motion, with the amendment, passed.

James gave an update on finances, pointing Board members to the appendix for further supporting information. The revenue goal for 2020 was revised from \$445K to \$200K due to the impact of the coronavirus and moving an anticipated capital campaign to 2021. Goals for the last quarter include bringing in new donors, new relationship, and having a good end of the year campaign. He also hopes to get grant applications out by end of year. The timber harvest on Camano should be happening in a couple of weeks. So far in 2020, we have spent down our savings by about \$66,000, which was the plan since the beginning of 2020. The cash on hand is still pretty strong (\$112,450). Our best estimate of income and expenses through the end of the year is a small total loss of about \$17,000 for 2020. These are conservative projection of both expenses and income as we hope to connect with some more people and may also have more expenses in Camano development. Louise pointed out that the in-kind land gift given this year is excluded from budget vs. expense reports in the appendix, but the balance sheet does include this gift. The land value was derived from the land appraisal done at the time of the gifting. The Board moved to accept the financial report and the motion was seconded and approved.

Objectives, Strategies and Key Results.

Camano Project: The timber harvest is going forward in mid-October. The team is working hard on the access road project by working with a surveyor, land use attorney and neighbors to put together the best plan that makes most sense for everyone. Good progress has been made and the hope is to have an application to the county to open the road by end of 2020. A new design partner--Terra Phoenix Design has been brought in. They specialize in thinking about projects like this from a whole-project and permaculture perspective. We are waiting to hear their proposal on their involvement and we are hoping to have a master plan to share with people by the end of the year. Someone ran through the gate to our property and severely damaged it. We have talked with neighbors about people running through the property on ATV's at all hours and have determined it is a very small number of people. Through these conversations, good connections with neighbors have been made as we collaborate on the issues. James and Forrest have made many of these connections.

Circlewood's Voice & Community: The podcast continues to reach new listeners. Forrest is doing an awesome job putting together compelling episodes. James and Forrest have lots of creative ideas, some which are being set aside until there is more time to do them. We are offering *The Bible, Ecology, and Practical Earthkeeping* again this fall. Anna Carlson is facilitating the class and we have made a few improvements. We have some new volunteers who are going to help us in the areas of social media and general communication strategy.

Circlewood's core: Have begun to plan for increases in staff roles next year. This will be part of our budget presentation and discussion at our next board meeting. We plan to move James to ¾ time, add some hours to Louise's time, and are looking ahead further into 2021 to how we can expand Forrest's role.

Resource for Growth: Dave talked about Tara Britton, the grant developer we have contracted with. Many of David's connections from the past are more evangelical and less in line with environmental issues. He introduced Tara's experience and his impressions of her. We have asked her to create a 40-foundation profile. She will identify foundations that align with what we're trying to do and provide us with useful information about that foundations, including deadlines, involvement, etc. We provided her with a preliminary list of projects we consider fundable so she can begin to match that list with possible grants. She is capable of a wide range of tasks, including preliminary work, grant writing, and grant assessment. We should have the foundation profile list by end of month and may have one or two places where we could send letters of interest to by end of year.

Vision planning: David and James want to bring more people into the brainstorming and collaboration process to discern where Circlewood might be heading. The goal is to identify places where board members are already involved or where they would like to have more of a voice and then create a format to explore that area together, putting goals in place for 2021. In late October, David and James will contact board members to invite people onto these teams, with November meetings planned. There will probably be two meetings, which will start with everyone together and then break into smaller groups.

Glenn and James brought a proposal in partnership with the resource team and Camano development team: Authorization to pursue housing options on Camano. As we gear up to do things programmatically and with development on Camano, it is becoming increasingly important to have people on site—learning, interacting with neighbors, problem solving, building support and providing basic security. We need an in-person, on-site communication person. There are two options:

- 1. Purchase a tiny home or RV, which is off-grid capable, can be driven onto the land, install someone to explore that lifestyle for a few months who can act as a Circlewood ambassador, learn more about the forest. James talked to one person, but doesn't think it's the right person and stated that finding the right person is harder than finding a home or RV that would work.
- 2. Noticed some months ago a nearby property on the market, which almost backs up to our access road. Have dreamt for a while about forest and farm presence on Camano. This property would allow that. It is two acres, has a 2500 sq. ft. home, a detached garage with an apartment, a view of Puget Sound, and a large field. James shared PowerPoint pictures of the property and location. James, Tom and Forrest have walked on the land. They have contacted a realtor friend of Forrest's. There is a three-month old pending offer on the property, which is delayed due to

Issues with the seller. We have been encouraged to put together a back-up offer if the Board is interested in pursuing this. The estimated cost is between \$550K-600K. A generous donor has offered the first \$200k as a down payment. There are a couple of different options for purchase:

- 1. Pursue Circlewood ownership through combination of gifts and loans
- 3. Independent ownership by someone else but in partnership w/Circlewood in terms of use, lease, option to own in future. If the Board agrees and gives authority, the resource team would iron out details. Although this is unexpected, James has thought and talked to people about it, and it would allow us to start programming and plant something sooner than anticipated. Glenn expressed his excitement that this would allow us to move ahead much more quickly than otherwise. He suggested we start to get ready and if this property doesn't work out, we would be ready if another opportunity came. Forrest has had direct conversation with the seller's realtor and our realtor; the house is in foreclosure, with at least three banks holding a claim, so title is not free and clear and there no telling how long it will take to resolve. We could put together offer in case it becomes available again. The property was listed on Zillow in June for \$550K, the Zillow estimate is \$750K. The current offer is \$595K and has changed from a cash offer to a financed offer. With the changed offer, that offer may no longer have precedence. There is a tentative appointment next Tuesday (Oct 6th) to see the property with our realtor, and maybe seller's realtor. The two proposals were discussed and people mentioned many positive opportunities this property would provide to Circlewood. The Board was unanimous in their enthusiasm about the 2nd option. A proposal was introduced; discussion continued. The final proposal was as follows: The board authorizes Forrest and James to work with the Resource team to put an offer together on the house for up to \$650K and to consult the Board as needed. The motion passed. A vote on the other proposal was set aside on as the Board decided to focus on this option for now and will return to the other option if this option fall through.

Circlewood is holding an October 29th Zoom event. It stemmed from David and James thinking about lack of ability to meet w/people who might want to learn about Circlewood. Goals of the evening: 1. Encourage people 2. Draw people by having Mike's name attached 3. Provide an opportunity to talk about Circlewood. 4. Provide options for people to connect with Circlewood. The name is: Signs of Hope in a Troubled World: A Circlewood Webinar hosted by Mike Holmgren. James commented that people are hungry for this. There are lots of things to be worried and anxious about, and angry about. We will be highlighting people and places who are working hard to imagine and work toward an alternative future, which is the kind of transformation that Circlewood is wanting to foster and support. We hope to gather existing Circlewood friends, make a chance to invite new people in to get a sense of who we are, and give people ways to connect with us. The program will be tight and engaging. The Board can be involved by attending if possible, promoting the event on social media and sending emails. Board involvement—attend if you can, promote on social media, email to send out, and personally invite 2-5 people who might enjoy the event and be interested in our work. It will be a Zoom webinar and will be broadcast on Facebook Live.

Glenn affirmed James' leadership and reflected on Circlewood's progress in the last couple of years.

It was moved, seconded and passed that the meeting be adjourned. Tim closed the meeting in prayer. Next Meeting—December—Specific date TBD

- Forrest, James, Resource Team-- put an offer together on the Camano property for up to \$650K and consult the Board as needed.

Further resolved, that the Executive Director and Chairperson are hereby authorized to request payments from this account.

Conflict of Interest Policy

Adopted:

1. PURPOSE

The purpose of this Conflict of Interest Policy (the "Policy") is to protect the interests of Circlewood in connection with any transaction or arrangement that might benefit the private interests of any Covered Person, as defined below. This Policy provides (i) a systematic mechanism for disclosing and evaluating potential and actual conflicts; and (ii) procedures for the Board of Directors in considering any transaction or arrangement where a conflict may exist.

2. PERSONS COVERED BY THE POLICY

This policy applies to "Covered Persons," defined as any Corporation director, officer, or member of any committee of the Corporation's Board of Directors that has authority to act on behalf of the Board of Directors.

3. DUTIES OF COVERED PERSONS

- Duty of Care. Every Covered Person shall perform his or her duties for the Corporation in good faith and with the degree of care that an ordinarily prudent person would exercise under similar circumstances.
- 2. Duty of Loyalty. Every Covered Person must act with loyalty to the Corporation, meaning that no Covered Person may use his or her position with the Corporation to make personal profit or gain other personal advantage. No Covered Person may personally take advantage of a business opportunity that is offered to the Corporation unless the Board of Directors determines (after full disclosure and a disinterested and informed evaluation) not to pursue that opportunity.
- 3. Conflicts of Interest. No Covered Person may engage in any transaction or arrangement or undertake positions with other organizations that involve a conflict of interest, except in compliance with this Policy. Covered Persons should avoid both actual conflicts and the appearance of conflicts of interest. Every Covered Person shall:
 - i. Disclose all actual and potential conflicts as set out below in Section 5; and
 - ii. Recuse himself/herself from voting on any transaction or arrangement in which he/she has a potential or actual conflict of interest and shall not be present when any such vote is taken.

4. CONFLICT OF INTEREST

- 1. Potential Conflict. A Covered Person may have a conflict of interest with respect to a transaction or arrangement whenever he or she, or any of his or her family members:
 - Receives compensation or other funding directly or indirectly from the Corporation and the transaction or arrangement involves such compensation or funding (other than a Covered Person's receipt of regular salary or Board of Directors fees from the Corporation);

- ii. Has or anticipates having a compensation arrangement with any entity or individual that either: (a) sells goods or services to, or purchases services from, the Corporation; (b) has any other transaction or arrangement with the Corporation; or (c) competes with the Corporation;
- iii. Has or anticipates having any ownership or investment interest in, or serves or anticipates serving as a director or officer of, any entity that either: (a) sells goods or services to, or purchases services from, the Corporation; (b) has any other transaction or arrangement with the Corporation; or (c) competes with the Corporation; or
- iv. Has accepted any gift, entertainment, or other favor or item of value where such acceptance might create the appearance of influence on the Covered Person (other than gifts of nominal value, which are clearly tokens of respect and friendship unrelated to any particular transaction).
- 2. No Conflict. A Covered Person does not have a conflict of interest if the Covered Person owns securities of a publicly traded company with which the Corporation has a transaction or arrangement if:
 - i. Such securities are less than 5% of the outstanding securities of the publicly traded company; and
 - ii. Their fair market value is less than 5% of the Covered Person's annual gross income.
- 3. Irreconcilable Conflict. Covered Persons shall not engage in any of the following actions:
 - i. Represent clients or vendors before the Board of Directors for compensation;
 - ii. Represent any claimant requesting compensation or damages from the Corporation; or
 - iii. Accept employment, or engage in any business, or be involved in any activity which one might reasonably expect would require disclosure of privileged information gained by virtue of their official duties at the Corporation.

5. DISCLOSURE AND EVALUATION OF CONFLICTS

- 1. Each Covered Person shall promptly and fully disclose all material facts of every actual or potential conflict of interest:
 - i. Existing at the time when he/she becomes a Covered Person;
 - ii. That arises while he/she is a Covered Person, at the time such actual or potential conflict arises; and
 - iii. Annually in conjunction with his/her delivery of his/her acknowledgement of this Policy.
 - iv. All disclosures involving a transaction or arrangement being considered at a meeting of the Board of Directors or a committee shall be made to all members present at such meeting. All other disclosures shall be made to the President (who shall disclose his or her conflicts to the Board of Directors).
- 2. Evaluation. The President shall disclose to the Board of Directors all conflicts of interest reported to him or her under this Policy. The Board of Directors will evaluate the disclosures to determine whether they involve actual conflicts of interest and may attempt to develop alternatives to remove the conflict from the situation.

6. PROCEDURES FOR ACTING ON CONFLICT OF INTEREST TRANSACTIONS

1. Formal Approval. The Corporation may enter into a transaction or arrangement in which a Covered Person has a conflict of interest if:

- i. The Covered Person has disclosed the conflict of interest in accordance with this Policy;
- ii. A majority of directors who have no interest in the transaction or arrangement approve the transaction or arrangement at a Board of Directors or committee meeting after determining, in good faith and after reasonable investigation, that the transaction or arrangement is fair and reasonable to the Corporation and is in the Corporation's best interest;
- iii. Any Covered Person who has an actual or potential conflict with respect to the transaction or arrangement does not participate in and is not present for the vote regarding any such transaction or arrangement (provided, however, that any such Covered Person may appear at a meeting to answer questions concerning the transaction or arrangement); and
- iv. The Board of Directors relies upon appropriate comparability data, such as an independent appraisal or an independent compensation study, in reaching its determination as to the fairness and reasonableness of the transaction or arrangement to the Corporation.
- 2. Transaction Fair to the Corporation. It shall not be a violation of this Policy if all the requirements for formal approval, outlined above, are not satisfied, so long as the transaction or arrangement is in fact fair to the Corporation.
- 3. Irreconcilable Conflicts. Notwithstanding anything in this Policy to the contrary, no action or transaction identified in Section 4(c) that is taken or proposed to be taken by a Covered Person shall be approved by the Board of Directors and the taking of such action by a Covered Person shall be a violation of this Policy.

7. RECORDS OF PROCEEDINGS

The minutes of the Board of Directors or any committee of the Board of Directors for any meetings described above shall contain:

- 1. The names of the persons who disclosed an actual or potential conflict of interest or otherwise were found to have a conflict of interest, and the nature of the conflict of interest; and
- The names of the persons who were present for discussions and votes relating to the transaction
 or arrangement, the content of the discussion, including any alternatives to the proposed
 transaction or arrangement considered and the appropriate comparability data relied upon, and a
 record of any votes taken.

8. ENFORCEMENT

Each Covered Person shall sign a statement acknowledging that he or she has received a copy of this Policy, has read and understands it, and agrees to comply with it. If the Board of Directors has reasonable cause to believe that a Covered Person has failed to comply with this Policy, the Board of Directors may counsel the Covered Person regarding such failure and, if the issue is not resolved to the Board of Directors' satisfaction, may consider additional corrective action as appropriate.



Circlewood Board Meeting Minutes September 30, 2020, 3:00 pm, via Zoom

Present: Glenn Palmberg, James Amadon, Mike Holmgren, Tim Hedberg, Lenore Three Stars, Tom Ruebel, Forrest Inslee, Beth Knox, Louise Conner, Guest: David Jones

Check in: James shared a poll, with questions about each board members to open the meeting and begin check-ins. Glenn opened the meeting in prayer. A motion was made to approve the minutes as amended. The motion was seconded and passed.

Glenn and James presented the "Board Nomination Process, Guidelines, and Current Board Member Terms" proposal to the board. Proposed terms are intended to stagger terms and listed start dates are somewhat artificial in order to accomplish this aim. Glenn and James proposed that the Board adopt the proposed 6 steps as our board nomination process and guidelines from this day forward, and the term descriptions of current members as outlined. Discussion was held on which term this should be for Forrest. His current term was changed to his first term from second term. The motion, with the amendment, passed.

James gave an update on finances, pointing Board members to the appendix for further supporting information. The revenue goal for 2020 was revised from \$445K to \$200K due to the impact of the coronavirus and moving an anticipated capital campaign to 2021. Goals for the last quarter include bringing in new donors, new relationship, and having a good end of the year campaign. He also hopes to get grant applications out by end of year. The timber harvest on Camano should be happening in a couple of weeks. So far in 2020, we have spent down our savings by about \$66,000, which was the plan since the beginning of 2020. The cash on hand is still pretty strong (\$112,450). Our best estimate of income and expenses through the end of the year is a small total loss of about \$17,000 for 2020. These are conservative projection of both expenses and income as we hope to connect with some more people and may also have more expenses in Camano development. Louise pointed out that the in-kind land gift given this year is excluded from budget vs. expense reports in the appendix, but the balance sheet does include this gift. The land value was derived from the land appraisal done at the time of the gifting. The Board moved to accept the financial report and the motion was seconded and approved.

Objectives, Strategies and Key Results.

Camano Project: The timber harvest is going forward in mid-October. The team is working hard on the access road project by working with a surveyor, land use attorney and neighbors to put together the best plan that makes most sense for everyone. Good progress has been made and the hope is to have an application to the county to open the road by end of 2020. A new design partner--Terra Phoenix Design has been brought in. They specialize in thinking about projects like this from a whole-project and permaculture perspective. We are waiting to hear their proposal on their involvement and we are hoping to have a master plan to share with people by the end of the year. Someone ran through the gate to our property and severely damaged it. We have talked with neighbors about people running through the property on ATV's at all hours and have determined it is a very small number of people. Through these conversations, good connections with neighbors have been made as we collaborate on the issues. James and Forrest have made many of these connections.

Circlewood's Voice & Community: The podcast continues to reach new listeners. Forrest is doing an awesome job putting together compelling episodes. James and Forrest have lots of creative ideas, some which are being set aside until there is more time to do them. We are offering *The Bible, Ecology, and Practical Earthkeeping* again this fall. Anna Carlson is facilitating the class and we have made a few improvements. We have some new volunteers who are going to help us in the areas of social media and general communication strategy.

Circlewood's core: Have begun to plan for increases in staff roles next year. This will be part of our budget presentation and discussion at our next board meeting. We plan to move James to ¾ time, add some hours to Louise's time, and are looking ahead further into 2021 to how we can expand Forrest's role.

Resource for Growth: Dave talked about Tara Britton, the grant developer we have contracted with. Many of David's connections from the past are more evangelical and less in line with environmental issues. He introduced Tara's experience and his impressions of her. We have asked her to create a 40-foundation profile. She will identify foundations that align with what we're trying to do and provide us with useful information about that foundations, including deadlines, involvement, etc. We provided her with a preliminary list of projects we consider fundable so she can begin to match that list with possible grants. She is capable of a wide range of tasks, including preliminary work, grant writing, and grant assessment. We should have the foundation profile list by end of month and may have one or two places where we could send letters of interest to by end of year.

Vision planning: David and James want to bring more people into the brainstorming and collaboration process to discern where Circlewood might be heading. The goal is to identify places where board members are already involved or where they would like to have more of a voice and then create a format to explore that area together, putting goals in place for 2021. In late October, David and James will contact board members to invite people onto these teams, with November meetings planned. There will probably be two meetings, which will start with everyone together and then break into smaller groups.

Glenn and James brought a proposal in partnership with the resource team and Camano development team: Authorization to pursue housing options on Camano. As we gear up to do things programmatically and with development on Camano, it is becoming increasingly important to have people on site—learning, interacting with neighbors, problem solving, building support and providing basic security. We need an in-person, on-site communication person. There are two options:

- 1. Purchase a tiny home or RV, which is off-grid capable, can be driven onto the land, install someone to explore that lifestyle for a few months who can act as a Circlewood ambassador, learn more about the forest. James talked to one person, but doesn't think it's the right person and stated that finding the right person is harder than finding a home or RV that would work.
- 2. Noticed some months ago a nearby property on the market, which almost backs up to our access road. Have dreamt for a while about forest and farm presence on Camano. This property would allow that. It is two acres, has a 2500 sq. ft. home, a detached garage with an apartment, a view of Puget Sound, and a large field. James shared PowerPoint pictures of the property and location. James, Tom and Forrest have walked on the land. They have contacted a realtor friend of Forrest's. There is a three-month old pending offer on the property, which is delayed due to

Issues with the seller. We have been encouraged to put together a back-up offer if the Board is interested in pursuing this. The estimated cost is between \$550K-600K. A generous donor has offered the first \$200k as a down payment. There are a couple of different options for purchase:

- 1. Pursue Circlewood ownership through combination of gifts and loans
- 3. Independent ownership by someone else but in partnership w/Circlewood in terms of use, lease, option to own in future. If the Board agrees and gives authority, the resource team would iron out details. Although this is unexpected, James has thought and talked to people about it, and it would allow us to start programming and plant something sooner than anticipated. Glenn expressed his excitement that this would allow us to move ahead much more quickly than otherwise. He suggested we start to get ready and if this property doesn't work out, we would be ready if another opportunity came. Forrest has had direct conversation with the seller's realtor and our realtor; the house is in foreclosure, with at least three banks holding a claim, so title is not free and clear and there no telling how long it will take to resolve. We could put together offer in case it becomes available again. The property was listed on Zillow in June for \$550K, the Zillow estimate is \$750K. The current offer is \$595K and has changed from a cash offer to a financed offer. With the changed offer, that offer may no longer have precedence. There is a tentative appointment next Tuesday (Oct 6th) to see the property with our realtor, and maybe seller's realtor. The two proposals were discussed and people mentioned many positive opportunities this property would provide to Circlewood. The Board was unanimous in their enthusiasm about the 2nd option. A proposal was introduced; discussion continued. The final proposal was as follows: The board authorizes Forrest and James to work with the Resource team to put an offer together on the house for up to \$650K and to consult the Board as needed. The motion passed. A vote on the other proposal was set aside on as the Board decided to focus on this option for now and will return to the other option if this option fall through.

Circlewood is holding an October 29th Zoom event. It stemmed from David and James thinking about lack of ability to meet w/people who might want to learn about Circlewood. Goals of the evening: 1. Encourage people 2. Draw people by having Mike's name attached 3. Provide an opportunity to talk about Circlewood. 4. Provide options for people to connect with Circlewood. The name is: Signs of Hope in a Troubled World: A Circlewood Webinar hosted by Mike Holmgren. James commented that people are hungry for this. There are lots of things to be worried and anxious about, and angry about. We will be highlighting people and places who are working hard to imagine and work toward an alternative future, which is the kind of transformation that Circlewood is wanting to foster and support. We hope to gather existing Circlewood friends, make a chance to invite new people in to get a sense of who we are, and give people ways to connect with us. The program will be tight and engaging. The Board can be involved by attending if possible, promoting the event on social media and sending emails. Board involvement—attend if you can, promote on social media, email to send out, and personally invite 2-5 people who might enjoy the event and be interested in our work. It will be a Zoom webinar and will be broadcast on Facebook Live.

Glenn affirmed James' leadership and reflected on Circlewood's progress in the last couple of years.

It was moved, seconded and passed that the meeting be adjourned. Tim closed the meeting in prayer. Next Meeting—December—Specific date TBD

Conflict of Interest Policy

Adopted:

1. PURPOSE

The purpose of this Conflict of Interest Policy (the "Policy") is to protect the interests of Circlewood in connection with any transaction or arrangement that might benefit the private interests of any Covered Person, as defined below. This Policy provides (i) a systematic mechanism for disclosing and evaluating potential and actual conflicts; and (ii) procedures for the Board of Directors in considering any transaction or arrangement where a conflict may exist.

2. PERSONS COVERED BY THE POLICY

This policy applies to "Covered Persons," defined as any Corporation director, officer, or member of any committee of the Corporation's Board of Directors that has authority to act on behalf of the Board of Directors.

3. DUTIES OF COVERED PERSONS

- Duty of Care. Every Covered Person shall perform his or her duties for the Corporation in good faith and with the degree of care that an ordinarily prudent person would exercise under similar circumstances.
- 2. Duty of Loyalty. Every Covered Person must act with loyalty to the Corporation, meaning that no Covered Person may use his or her position with the Corporation to make personal profit or gain other personal advantage. No Covered Person may personally take advantage of a business opportunity that is offered to the Corporation unless the Board of Directors determines (after full disclosure and a disinterested and informed evaluation) not to pursue that opportunity.
- 3. Conflicts of Interest. No Covered Person may engage in any transaction or arrangement or undertake positions with other organizations that involve a conflict of interest, except in compliance with this Policy. Covered Persons should avoid both actual conflicts and the appearance of conflicts of interest. Every Covered Person shall:
 - i. Disclose all actual and potential conflicts as set out below in Section 5; and
 - ii. Recuse himself/herself from voting on any transaction or arrangement in which he/she has a potential or actual conflict of interest and shall not be present when any such vote is taken.

4. CONFLICT OF INTEREST

- 1. Potential Conflict. A Covered Person may have a conflict of interest with respect to a transaction or arrangement whenever he or she, or any of his or her family members:
 - Receives compensation or other funding directly or indirectly from the Corporation and the transaction or arrangement involves such compensation or funding (other than a Covered Person's receipt of regular salary or Board of Directors fees from the Corporation);

- ii. Has or anticipates having a compensation arrangement with any entity or individual that either: (a) sells goods or services to, or purchases services from, the Corporation; (b) has any other transaction or arrangement with the Corporation; or (c) competes with the Corporation;
- iii. Has or anticipates having any ownership or investment interest in, or serves or anticipates serving as a director or officer of, any entity that either: (a) sells goods or services to, or purchases services from, the Corporation; (b) has any other transaction or arrangement with the Corporation; or (c) competes with the Corporation; or
- iv. Has accepted any gift, entertainment, or other favor or item of value where such acceptance might create the appearance of influence on the Covered Person (other than gifts of nominal value, which are clearly tokens of respect and friendship unrelated to any particular transaction).
- 2. No Conflict. A Covered Person does not have a conflict of interest if the Covered Person owns securities of a publicly traded company with which the Corporation has a transaction or arrangement if:
 - i. Such securities are less than 5% of the outstanding securities of the publicly traded company; and
 - ii. Their fair market value is less than 5% of the Covered Person's annual gross income.
- 3. Irreconcilable Conflict. Covered Persons shall not engage in any of the following actions:
 - i. Represent clients or vendors before the Board of Directors for compensation;
 - ii. Represent any claimant requesting compensation or damages from the Corporation; or
 - iii. Accept employment, or engage in any business, or be involved in any activity which one might reasonably expect would require disclosure of privileged information gained by virtue of their official duties at the Corporation.

5. DISCLOSURE AND EVALUATION OF CONFLICTS

- 1. Each Covered Person shall promptly and fully disclose all material facts of every actual or potential conflict of interest:
 - i. Existing at the time when he/she becomes a Covered Person;
 - ii. That arises while he/she is a Covered Person, at the time such actual or potential conflict arises; and
 - iii. Annually in conjunction with his/her delivery of his/her acknowledgement of this Policy.
 - iv. All disclosures involving a transaction or arrangement being considered at a meeting of the Board of Directors or a committee shall be made to all members present at such meeting. All other disclosures shall be made to the President (who shall disclose his or her conflicts to the Board of Directors).
- 2. Evaluation. The President shall disclose to the Board of Directors all conflicts of interest reported to him or her under this Policy. The Board of Directors will evaluate the disclosures to determine whether they involve actual conflicts of interest and may attempt to develop alternatives to remove the conflict from the situation.

6. PROCEDURES FOR ACTING ON CONFLICT OF INTEREST TRANSACTIONS

1. Formal Approval. The Corporation may enter into a transaction or arrangement in which a Covered Person has a conflict of interest if:

- i. The Covered Person has disclosed the conflict of interest in accordance with this Policy;
- ii. A majority of directors who have no interest in the transaction or arrangement approve the transaction or arrangement at a Board of Directors or committee meeting after determining, in good faith and after reasonable investigation, that the transaction or arrangement is fair and reasonable to the Corporation and is in the Corporation's best interest;
- iii. Any Covered Person who has an actual or potential conflict with respect to the transaction or arrangement does not participate in and is not present for the vote regarding any such transaction or arrangement (provided, however, that any such Covered Person may appear at a meeting to answer questions concerning the transaction or arrangement); and
- iv. The Board of Directors relies upon appropriate comparability data, such as an independent appraisal or an independent compensation study, in reaching its determination as to the fairness and reasonableness of the transaction or arrangement to the Corporation.
- 2. Transaction Fair to the Corporation. It shall not be a violation of this Policy if all the requirements for formal approval, outlined above, are not satisfied, so long as the transaction or arrangement is in fact fair to the Corporation.
- 3. Irreconcilable Conflicts. Notwithstanding anything in this Policy to the contrary, no action or transaction identified in Section 4(c) that is taken or proposed to be taken by a Covered Person shall be approved by the Board of Directors and the taking of such action by a Covered Person shall be a violation of this Policy.

7. RECORDS OF PROCEEDINGS

The minutes of the Board of Directors or any committee of the Board of Directors for any meetings described above shall contain:

- 1. The names of the persons who disclosed an actual or potential conflict of interest or otherwise were found to have a conflict of interest, and the nature of the conflict of interest; and
- The names of the persons who were present for discussions and votes relating to the transaction
 or arrangement, the content of the discussion, including any alternatives to the proposed
 transaction or arrangement considered and the appropriate comparability data relied upon, and a
 record of any votes taken.

8. ENFORCEMENT

Each Covered Person shall sign a statement acknowledging that he or she has received a copy of this Policy, has read and understands it, and agrees to comply with it. If the Board of Directors has reasonable cause to believe that a Covered Person has failed to comply with this Policy, the Board of Directors may counsel the Covered Person regarding such failure and, if the issue is not resolved to the Board of Directors' satisfaction, may consider additional corrective action as appropriate.

August – Had follow up meeting with Terra Phoenix Design. Asked the to put together proposal for their engagement


September – Camano Development Team met. Had vision meeting with David Vandervort Architects. Met with 3 key neighbors.

Circlewood Board Meeting December 4, 2020 via zoom

Present: James Amadon, Glenn Palmberg, Tim Hedberg, Lenore Three Stars, Forrest Inslee, Beth Knox, Tom Ruebel, Mike Holmgren, Louise Conner. Guest: David Jones.

There was a check-in of those present. The meeting was opened in prayer. James shared a zoom poll, which was followed by an overview of the meeting.

Glenn presented the minutes for the last meeting. Forrest moved to approve the minutes as presented in the meeting packet. Tom seconded the motion. The motion passed.

A short Nominating Committee Meeting was held. Beth was appointed as chair while Glenn and Tim absented themselves during the discussion of their terms. According to the nominating policy adopted at our last meeting, Glenn and Tim's current terms will expire at the end of December, 2020. Both are open and eager to serve second terms as Board members if the Board wishes them to. After affirmative comments, Beth entertained a motion to extend an invitation for a second three-year term for both Glenn and Tim; Tom made the motion; Mike seconded the motion. The motion passed. Glenn and Tim returned to the meeting and both accepted the invitation. Their second Circlewood terms will begin on 1/1/2020 and will run until 12/31/2023.

Conflict of Interest Policy: James introduced the draft Conflict of Interest Policy. Forrest moved to approve. Tom seconded. The motion passed. James and Louise will implement the questionnaire portion of the policy beginning in January.

Financial Updates: James referred people to the packet, with additional information in the back. Profit and Loss as of Nov. 30 is -\$77,629. We expect year-end giving in December to cut this loss and the loss is not unexpected this year as we expanded our work this past year. The PPP loan has been fully forgiven. Cash on hand total reflects funds in Trust account that was voted on last month (\$300K gift, \$350K loan for farm property). The Projected cash flow for the year is anticipated to be an annual loss of \$26,310.

OSKR Update:

Camano: The timber harvest scheduled has been readjusted. Preparation work on access road for timber harvest should be started and completed by the end of the year, which we hope will help the long-term access road project work as well. Entrance will be widened to nine feet and turnouts will be added. We will use a different timber company than originally planned for due to their proposed cost. A contract with a new forester is in process, with the harvest to take place in January. Expenses from the harvest will be in 2020, while the income will be pushed into 2021. James is reviewing a proposal submitted by David Vandervort for more thorough design work over the next six to eight months. There is a need to balance what should be done now and what should wait until questions such as road accessibility are more settled. A project manager is a need in this area and options are being explored. James wants to schedule Camano Development team meeting soon to catch everyone up and chart out what is possible over the next year. Update on Camano property that we made offer on was given. The offer was not really considered since it was a bank manager looking at offers. The new owners are property investors and have begun gutting the house and plan to upgrade it and possible live in it.

Emerging 2021 Goals:

James is working on possible 2021 projects and the budget for those. The podcast now has over 5000 downloads in first season and the downloads are steadily rising. A second Bible, Ecology and Practical Earthkeeping class was held and we are looking at and learning from the surveys. We hosted our first webinar with Mike, James appreciated having a seasoned pro as cohost. The feedback has been really good; people appreciated that we highlighted hope. While people need to know the bad news about the environment, purposefully highlighting the signs of hope around us is important also and that emphasis may become part of our Circlewood way of being. The second season of the podcast will launch in January. James is starting an hour a day of writing next week. There is an opportunity to bring on a social media coordinator. Additional webinars/live events bringing people together are also possible. The annual deep dive vision discussion was held and James felt it was good to expand the circle and have more voices at the table. James is prepared to go 34 time in January; Louise will add five to ten hours. Forrest plans to add more Circlewood hours in late spring/summer. David is continuing on, with shifted responsibilities. Creating a small board development team is anticipated.

Resource for Growth: The Circlewood stretch goal for 2020 was revised due to the coronavirus. Tara Britton has provided thorough profile of 70 foundations which might be good connections. She provided extra profiles voluntarily because she likes what we're doing. This will help us in 2021 as we will have some projects that are grant-ready. The current goal is to identify ten foundations from this list that we want to pursue and, with the Resource Team, determine next steps. An new idea is to develop forest products from Camano and create a Christmas shop next year. When we are able to invite people to the land, more opportunities will be opened up.

2021 Budget Proposal. To allow some plans to be made without having all the budget details resolved, a preliminary budget was presented at this meeting and a finalized 2021 budget proposal will be brought to the first meeting of 2021. There were three proposed staff positions changes: James, Louise, and a social media coordinator. Numbers for the Project Budget are not known yet. The proposal was to approve a preliminary Operating Budget and Project Budget, with the assumption that we will come back to the board in early 2021 with a finalized budget.

James, Louise, Forrest and David left the meeting during discussion of the staff section of the budget proposal.

(Secretary was absent during budget discussion and any votes that were taken. Per others present, Glenn asked the Board for permission to purchase a Christmas gift for James and Emily on behalf of the Board and the Board approved that purchase. The Board voted on and approved a preliminary 2021 Operating Budget and preliminary 2021 Project Budget.)

James, Louise, Forrest, and David returned to the meeting.

James presented a Proposal for Potential Farm on Camano. James and Forrest have created a list of criteria, James does not anticipate a rush to implement this proposal on a new property.

The following proposal was presented: That the board authorize Forrest and James to work with the Resource team to offer up to \$650K on a suitable property, and to consult the Board as needed. Lenore asked if the gift and loan were tied to the particular piece of property. Glenn stated that it was not. Mike asked if there was any chance of purchasing the original property from the new owners so that they could avoid their planned remodeling costs. James stated that if the proposal was passed, it

would include that property as well as new possibilities. He wants the Resource team to meet soon to look into options of pursuing that property further.

Glenn entertained the motion to adopt the Proposal for a Potential Farm on Camano. Lenore made the motion and Mike seconded the motion. The proposal was passed.

James proposed that the Resource Team stay on for a short meeting, depending on how things go with the Sines.

Tom and Christine Sine joined the meeting. Reflections on the Sines, their legacy, and our common vision were shared. The Sines opened their gifts. They expressed their appreciation for the gifts and their desire to continue to support Circlewood and its ongoing vision. Tim led a prayer. The Sines left the meeting. Glenn closed the meeting.

Next meeting—late January or February. Lenore expressed the desire to be introduced to the Sines if/when they are part of a Circlewood meeting in the future.

After technical difficulties, the meeting was adjourned.
